Agenda Item I - Call to Order

Vice Chair Darryl Bardusch called the meeting to order at 1:01 p.m.

Agenda Item II - Minutes

Mr. Leslie Chinen made a motion, seconded by Mr. Keith Matsumoto, to approve the minutes of the June 18, 2009 meeting as amended, amending the heading "Agenda IX" to "Agenda VI." The motion was unanimously carried.

Agenda Item III - Investigative Committee Report on proposed changes to HAR Section 3-125-13 (addition to the Price Adjustment Clause in Construction Contracts.)

Mr. Lance Inouye reported that the Investigative Subcommittee met twice and came up with proposed language amending HAR section 3-125-13 (Price Adjustment Clause in Construction Contracts) for submission to the PPB.

- Agenda Item IV For approval as interim HAR amendments to HAR Section 3-125-13 (addition of subsection (3) to the Price Adjustment clause in Construction Contracts.)
- Mr. Lance Inouye presented the PPB with further amendments to HAR section 3-125-13 (Price Adjustment Clause in Construction Contracts) in addition to what was previously submitted.
- Mr. Matsumoto made a motion, seconded by Mr. Chinen, to adopt the proposed amendments as further amended, as interim rules, HAR Section 3-125-13. The motion was unanimously carried.
- Agenda Item V Summary and results from public hearing and for the Procurement Policy Board's final approval of Hawaii Administrative Rules Chapters 3-120, 3-121, 3-125, 3-128 and 3-131
- Mr. Aaron Fujioka reported to the PPB that HAR Chapters 3-120, General Provisions; 3-121, Procurement Organization; 3-125, Modifications and Terminations of Contracts; 3-128, Governmental Relations and Cooperative Purchasing; and 3-131, Compliance are currently in effect as interim rules, as approved by the Board during prior meetings, with effective dates not to exceed 18 months while the public hearing process is conducted. The statewide public notice issued on June 10, 2009 announced the public hearing on the proposed amendments which was held on July 13, 2009 via video conference on Oahu, with the islands of Hawaii, Maui and Kauai. No verbal or written comments or testimony were received.
- Mr. Matsumoto made a motion seconded by Mr. Chinen to adopt HAR Chapters 3-120, General Provisions; 3-121, Procurement Organization; 3-125, Modifications and Terminations of Contracts; 3-128, Governmental Relations and Cooperative Purchasing; and 3-131, Compliance. The motion was unanimously carried.
- Agenda Item VI Procurement Policy Board adoption of proposed amendments and compilation of HAR Chapter 3-124, Subchapter 9, Small Business Preference Rules (Interim)
- Mr. Fujioka explained to the PPB that at the May 21, 2009 PPB meeting he stated that interim rules HAR Chapter 3-124, Subchapter 9 will expire on September 2, 2009. However, with the Small Business Utilization Council conducting ongoing discussions about possible amendments to Chapter 3-124, the SPO is recommending various amendments to and the continuation of Subchapter 9 as interim rules to facilitate continued input and amendments to the HAR.
- Mr. Matsumoto made a motion, seconded by Mr. Chinen, to approve the amendments to HAR Chapter 3-124, Subchapter 9, as further amended on page 3, 3 (B),to read "...'energy efficiency' using alternative energy." and adopt Chapter 3-124, as amended, as interim rules. The motion was unanimously carried.

# Agenda Item VI - Announcements

Mr. Fujioka announced the next PPB meeting is scheduled for Thursday, August 20, 2009 at 1:00 pm.

Mr. Matsumoto inquired about any legislative acts dealing with procurement. Mr. Fujioka said SB 21 became Act 150, to help expedite ARRA funds and HB 1470 became Act 175, which is an omnibus procurement bill dealing with exemptions, Hawaii products preferences, bonding, small purchase procurements and the protest process.

Deputy Attorney General Patricia Ohara requested an executive session with the Board to discuss with the Board its powers and liabilities relative to on-going matters in litigation.

Mr. Russ Saito made a motion, seconded by Mr. Matsumoto to go into an executive session to consult with the Board's attorney. The motion was unanimously carried.

The PPB went into executive session at 1:34 pm.

Vice Chair Bardusch called the meeting back to order at 1:50 pm.

Agenda Item VII - Adjournment

Mr. Matsumoto made a motion, seconded by Mr. Chinen, to adjourn the meeting. The motion was unanimously carried. The meeting was adjourned at 1:50 p.m.
